DepEd Order No. 53, s. 2003 on the Updated Guidelines on Grant of Vacation Service Credits to Teacher while Non-Teaching Personnel/Teaching Related Personnel shall be entitled Compensatory Time-Off (CTO) in accordance with Civil Service Commission and Department of Budget and Management Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered.

- 2. A monitoring team shall be organized to oversee the progress of the intensive training.
- 3. Proper decorum must be observed by all officials, coaches, chaperons, and athletes concerned. They are expected to perform their best for the productive participation of Team Bulacan in this regional conclave. A Parent's permits must be secured from all the athletes of Team Bulacan.
- 4. Coaches from private schools are requested to coordinate closely with DepEd Bulacan Division Sports Officer (Jay-Arr C. Tayao, DBA, EdD).
- 5. All expenses to be incurred relative to the conduct of this activity, such as school-based and subsidized training which shall be taken from the support given by Municipal LSB/schools/other sources. While, the centralized training shall be charged from the 2024 Provincial Special Education Funds, subject to the usual accounting and auditing rules and regulations.
- 6. All concerned are reminded to strictly adhere to the health and safety protocols against the spread of any infectious diseases.
- 7. This Memorandum shall serve as the travel authority of all concerned.
- 8. Strict compliance with the foregoing instructions is enjoined.
- 9. Immediate and wide dissemination of this Memorandum is desired.
