**UPDATES ON THE PREPARATION FOR THE NATIONAL LEARNING CAMP
IMPLEMENTATION FOR END-OF-SCHOOL-YEAR BREAK 2023-2024**

1. In consonance with the National Online Meeting in Preparation for the National Learning Camp (NLC) Implementation for End-of-School-Year (EoS) Break 2023-2024 held March 15, 2024 @ 1:00 PM via Zoom, this Office informs all concerned of the urgent matters discussed during the said virtual activity.
2. The NLC for EoS Break 2023-2024 will have the incoming Grades 7,8,9, and 10 and Grades 1, 2, and 3 for the following camps:
 - 2.1 Intervention Camp for high-need learners who require additional support in foundational Mathematics and English skills;
 - 2.2 Consolidation camp for learners who have shown proficiency in grade level competencies but may benefit from additional practice and application; and
 - 2.3 Enhancement camp for learners who demonstrated advanced proficiency in grade-level competencies.

It will be conducted for three (3) weeks:

Week 1 – July 1 to 5, 2024;

Week 2 – July 8 to 12, 2024;

Week 3 – July 15 to 19, 2024;

(Week 4 – Assessment, Data Organization and Analysis,
Post Survey)

3. The other updates are as follows:

3.1 The early registration for the NLC is from March 20 to 31, 2024;

- 3.2 Teacher will administer Comprehensive Rapid Learning Assessment (CRLA) and Reading and Mathematics Assessment (RMA) to incoming Grades 1 to 3 (currently enrolled K to Grade 2) starting March 25 to April 19, 2024;
 - 3.3 For Grades 7 to 10, the NLCA results/sample screening test in Reading and Math as bases for the inclusion in the camp;
 - 3.4 The number of learners in each camp will be the basis in determining the number of Learning Camp Volunteers (LCV) requirement for camp;
 - 3.5 The call for application for Learning Camp Volunteers is from March 20 to 31, 2024 (c/o the school head).
4. The soft copy of the recorded online meeting will be shared by the time it is received by the CID Office.
 5. Immediate and wide dissemination of this Memorandum is desired.
