Specifically, this involves setting up Child Protection Committees or Learner Rights and Protection Committees where sports venues and billeting quarters are situated.
- **Monitoring Tool:** To ensure compliance, a Learner Rights and Protection (LRP) Monitoring Tool is used for sports activities. This tool aligns with the 1987 Constitution, Article XV, Section 3 (2), which emphasizes the state's duty to defend children's rights, including protection from neglect, abuse, and cruelty.

This training and CLRAA 2024 proper will create a safe and respectful environment for learners during the event. As it's essential, let's prioritize their well-being and enjoyment while fostering a positive sports culture in the division and regional conclave.

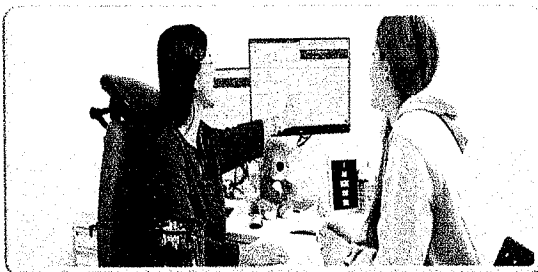

e. Observe the 4Rs for the Child Protection Policy- recognition of incident, recording, reporting and referral mechanisms in reporting safeguarding concerns, the following shall be communicated to the learner athletes:

DepEd SDO Bulacan in coordination with the Provincial Government of Bulacan-Provincial Youth and Sports Development Office has also used this Intensive Training (CLRAA Bounded Athletes Intensive Training) as a way to develop elite talent of the Province of Bulacan bound to CLRAA Meet and eventually at the Palarong Pambansa, thereby nurturing the athletes of promoting physical activity for the performance during the event competition proper.

These Five stages have been described including the following:

1. Fundamentals of Sports/Training per event
2. Training to Train
3. Training to Compete
4. Training to Win
5. Training to Sustain

The Physiological and Psychological Concerns with the Intensive Training

Intensive training in athletes, whether specialized or not, may potentially affect various components of their health, including cardiac, nutrition, maturation, musculoskeletal, and psychological. The musculoskeletal and psychological effects of intensive training in young athletes are covered in detail.

The SGOD-HNU of SDO Bulacan is the responsible unit for ensuring not only the physical fitness of the athletes, coaches, asst. coaches, and chaperons but to ensuring that physiological and Psychological Concerns with the Intensive Training are addressed.

There is support for closely monitoring nutritional intake in all youth athletes, especially those who participate in high-intensity and endurance sports, focusing particularly on caloric intake required to meet the demands of training as well as to maintain adequate growth and development.

General Guidance for the HNU, Parents/Guardians, Training Supervisors/Manager, Trainers, Coaches, Asst. Coaches, and Chaperons

The following guidance can be helpful for the implementation of Intensive Training from April 10 to 26 (15 Days):

1. The primary focus of sports for student-athletes should be to have fun and learn lifelong physical activity skills.
2. Participating in multiple sports, at least until puberty, decreases the chances of injuries, stress, and burnout in young athletes.
3. For most sports, specializing in a sport later (ie, late adolescence) may lead to a higher chance of the young athlete accomplishing his or her athletic goals.
4. Early diversification and later specialization provide for a greater chance of lifetime sports involvement, lifetime physical fitness, and possibly elite participation.

5. If a student-athlete has decided to specialize in a single sport, discussing his or her goals to determine whether they are appropriate and realistic is important. This discussion may involve helping the student-athlete distinguish these goals from those of the parents and/or coaches.
6. It is important for parents to closely monitor the training and coaching environment of CLRAA Intensive Training and relative sports programs and be aware of best practices for their children's sports.
7. Their sport of interest will allow for athletes' physical and psychological recovery. Young athletes can remain active in other activities to meet physical activity guidelines during the time off.
8. Young athletes having at least 1 to 2 days off per week from their sport of interest can decrease the chance of injuries.
9. Closely monitoring young athletes who pursue intensive training for physical and psychological growth and maturation as well as nutritional status is an important parameter for health and well-being.
10. The Training Managers/Trainers are responsible for the training matrix throughout the duration of intensive training and for ensuring the training is aligned with the existing guidelines and policies of DepEd Palarong Pambansa and integrating in all aspects of training the following DepEd Issuances:
