**Repair and Rehabilitation of Five Units of Two-Storey, Four-Classroom School Building (10 Classrooms on the Second Floor Only) at Felizardo C. Lipana National High School, Guiguinto, Bulacan**

1. The **Department of Education – Schools Division of Bulacan**, through the **CY 2024 Basic Education Facilities Fund (BEFF) – Repair/Rehabilitation of Classrooms Program** intends to apply the sum of **FOUR MILLION FOUR HUNDRED THOUSAND (Php 4,400,000.00) PESOS** being the Approved Budget for the Contract (ABC) to payments under the contract for **Project No.: PB-24-002- Repair and Rehabilitation of Five Units of Two-Storey, Four-Classroom School Building (10 Classrooms on the Second Floor Only) at Felizardo C. Lipana National High School, Guiguinto, Bulacan**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Department of Education – Schools Division of Bulacan** now invites bids for the above Procurement Project. Completion of the Works is required **120 calendar days upon receipt of Notice to Proceed**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.


