Restoration of 10-Classroom Gabaldon School Building at Matias A. Fernando Memorial School, Angat, Bulacan

- 1. The Department of Education Schools Division of Bulacan, through the General Appropriations Act (GAA) 2024 Conservation and Restoration of Gabaldon School Building Program intends to apply the sum of TEN MILLION SIX HUNDRED SIXTY-TWO THOUSAND ONE HUNDRED SEVENTY-ONE AND 54/100 (Php 10,662,171.54) PESOS being the Approved Budget for the Contract (ABC) to payments under the contract for Project No.: PB-24-001- Restoration of 10-Classroom Gabaldon School Building at Matias A. Fernando Memorial School, Angat Bulacan. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Department of Education Schools Division of Bulacan now invites bids for the above Procurement Project. Completion of the Works is required 180 calendar days upon receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

- 5. A complete set of Bidding Documents may be acquired by interested bidders on the date and address specified below accomplishing a bidder's information sheet, payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB in the amount of Twenty-Five Thousand Pesos (\$\mathbb{P}25,000.00)\$ to DepEd SDO Bulacan Cashier.
