WHEREAS, during the submission and opening of sealed bids held at the 3<sup>rd</sup> Floor Conference Hall, DepEd Division Office, City of Malolos on **December 27, 2023, 9:01:00 AM**, only one (1) bidder submitted ~~their~~ bid, copies of the Minutes of Bid Opening, Abstract of Bids as Read and Checklist for Bid Opening are attached and marked as Annexes "D", "E"; and "F", respectively;
