WHEREAS, the Pre-Bid Conference was held on **December 14, 2023, at 1:00:00 PM** at the Schools Division Office of Bulacan wherein important matters pertaining the competitive bidding and the rudiments of its conduct were discussed with prospective bidders and representatives of some bidders, with the end users and observers in attendance, minutes of the meeting is attached and marked as Annex "C";

WHEREAS, during the submission and opening of sealed bids held at the 3rd Floor Conference Hall, DepEd Division Office, City of Malolos on **December 27, 2023, 1:01:00 PM**, only one (1) bidder submitted ~~their bids~~, copies of the Minutes of Bid Opening, Abstract of Bids as Read and Checklist for Bid Opening are attached and marked as Annexes "D", "E"; and "F", respectively;

WHEREAS, in order to determine the Lowest Calculated Bid, a Detailed Evaluation and Comparison of Bids was held on January 2-5, 2024, copy of the Evaluation Report and the Abstract of the Bid as Calculated are hereto attached and marked as Annexes "G" and "H" respectively;

WHEREFORE, all premises considered, the Committee resolved as it is hereby resolved, to recommend to the Head of the Procuring Entity the award of contract to


