Submission of documents shall be on August 14, 2024. No additional documents will be accepted after the scheduled date of the ranking procedure.
  - a. Letter of Intent
  - Official Transcript of Records with Certification, Authentication, Verification (CAV) from CHED
  - c. Updated Service Records
  - d. Latest CSC Attested Appointment (or SDS signed appointment in lieu of attested appointment if still not released by CSC)
  - e. Performance Rating for three (3) consecutive rating periods
  - f. Certificates, MOVs and other documents determinants (A-H) for ranking of Master Teacher I and Master Teacher II.
- Only applicants from Virginia Ramirez Cruz NHS are eligible to apply for reclassification.
- 7. Reiteration of MEC Order No. 10, s. 1979 shall apply on the deployment of Master Teachers.
