GUIDELINES AND MECHANICS OF THE 2024 DIVISION WORLD FOOD DAY ON-THE-SPOT POSTER MAKING CONTEST

- 2. The poster should be an original creation of the contestant depicting the given theme of the contest, which will be written outside, and not incorporated in the artwork. There must be a 1-inch border on all sides, and the theme shall be written above or outside the border. Contestant who will not follow instruction will automatically be disqualified.
- 3. Contestants are required to wear their uniform throughout the contest.
- 4. The materials for the Poster Making Contest, an illustration board (20"x30"), oil pastel and pentel pen.
- 5. Judging shall immediately commence after entries have been completed based on the allotted time. Coaches and guardians are not allowed inside the venue during the contest proper. Only the Board of Judges (BOJ), Technical Working Group and Secretariat are allowed inside the contest area while evaluation is ongoing.
- 6. The decision of the BOJ shall be final and irrevocable. However, if the winner has been proven to commit misconduct (i.e. plagiarism, or any form of cheating), the award shall be withdrawn.
- 7. Winning entry shall become the property of the Department of Agriculture and Food and Agriculture Organization.
- 8. Criteria for Judging:
 Only the Best Three posters shall be selected as Division Winners based on the following criteria:

a. (Originality.	30%
b. (Creativity	30%
c. 1	Visual Impact	20%

I. RATIONALE

The Department of Agriculture (DA) has been the country's lead agency in the annual celebration of the World Food Day (WFD) in partnership with the Food and Agriculture Organization of the United Nations (FAO).

The annual Poster Making Contest has been one of the highlights of the WFD celebration, in coordination with the Department of Education (DepEd). The activity will involve elementary pupils from Grades V AND VI, who are enrolled in any public and Dep-Ed-accredited private elementary schools nationwide.

The WFD Poster Making Contest in the Regional level will be conducted On-the-Spot from August to September 2024 in their respective regions.

The WFD On-the-Spot Poster Making contest at the Regional level wil be conducted on September 24, 2024.

II. General Provisions

- The contest is open to all Grades V to VI elementary pupils enrolled in any public and DepEd-accredited private schools nationwide. Previous national winners of this contest are disqualified to join.
- Contestants are required to wear their uniform throughout the contest.
- 3. The poster should be an original creation of the contestant depicting the given theme of the contest, which will be written outside, and not incorporated in the artwork. There must be a 1-inch border on all sides, and the theme shall be writer above or outside the border. Contestants who will not follow instructions will automatically be disqualified.
- The theme for this year's On-the-Spot Poster Making Contest will be announced through communication channels upon official release by the FAO.
- The Contest Committee wil provide materials for the Poster Making Contest, which shall be limited to an illustration board (20"x30"), a specific brand of pastel (Faber Castell, Golden Oil, Pentel) and specific brand of pentel pen (Pentel/Stabilo) during the regional and national level.
- Judging shall immediately commence after all entries have been completed based on the allocated time. Coaches and guardians are not allowed inside the venue during the contest proper. Only the Board of Judges (BOJ), Technical Working

Group (TWG) and secretariat are allowed inside the contest area while the evaluation is ongoing.

7. The decision of the BOJ shall be final and irrevocable. However, if the winner has been proven to commit any misconduct (i.e. plagiarism, or any form of cheating), the title and the prize shall be withdrawn.

8. All entries shall become the property of the DA and FAO.

REGIONAL LEVEL

The poster making contest shall be conducted on-the-spot at the regional level (Division/District level contest may be conducted provided that expenses to be incurred shall be shouldered by the DepEd and/or DA regional offices).

- Each contestant may be accompanied by and shall be allowed to have one (1)
 coach or one (1) guardian to accompany him/her to the venue. However, neither
 the coach nor guardian are not allowed to enter or roam around the contest
 venue during the actual contest.
- 2. The regional winner will serve as the official entry and must be endorsed by the Regional On-The-Spot Poster Making Contest Committee to the National level.
- The Regional winner shall be allowed to have one (1) guardian or one coach to accompany him/her during the Nationa On-theOSpot Poster Making Contest in Quezon City.

NATIONAL LEVEL

The national On-the-Spot Poster Making Contest will be held at the DA Central Office in Diliman, Quezon City on Octover 14, 2024 (tentative date)

- Contest preliminaries will start at 8:00AM to 9:00AM, after which, contestants will be given a maximum three (3) hours to complete their posters.
- 2. The BOJ shall select the best five (5) posters among the entries.
- Winning entries will be displayed during the culminating activities of the WFD
 Celebration of October 16, 2024 in Quezon City. The best posters will be awarded
 on the same day.
- Winner of the Best Poster will receive a cash prize, trophy, and a certificate of recognition.

III. CRITERIA FOR JUDGING

Only the Best Five (5) Posters shall be selected as National Winners based on the following criteria:


IV. OBJECTIVES

 - b. 2nd Place PhP5,000.00
 - c. 3rdPlace-PhP3,000.00
 - d. consolation prize-Php1,000.00
- 2. The winning student shall become the official representative of Department of Agriculture Central Luzon.

National Level

The national On-the-Spot Poster Making Contest will be held at the DA Central Office in Diliman, Quezon City on October 14, 2024. (tentative date)

- Contest preliminaries will start at 8:00 AM to 9:00 AM, after which, contestants will be given a maximum of three (3) hours to complete their posters.
- 2. The BOJ shall select the best five (5) posters from among the entries.
- Winning entries will be displayed during the culminating activities of the WFD Celebration on October 16, 2024 in Quezon City. The best posters will be awarded on the same day.
- Winners of the Best Poster will receive a cash prize, trophy, and a certificate of recognition.
