### SPECIAL CURRICULAR PROGRAMS IN JOURNALISM AND FOREIGN LANGUAGE: A SECOND WAVE APPLICATION FOR POTENTIAL SECONDARY SCHOOL IMPLEMENTERS

- In line with the initiatives of the English Learning Area to further strengthen and hone the journalistic skills and linguistic competencies of learners under Project SPCJ (Sustaining Performance in Campus Journalism) and Project FLIS (Foreign Language Interest of Students), this Office calls for the second wave of application for potential secondary school implementers of Special Curricular Programs in Journalism and Foreign Language.
- 2. This initiative has the following objectives:
  - 2.1 support the secondary school learners on their special interest programs;
  - 2.2 sustain the performance of SDO Bulacan in campus journalism in individual writing categories, team events, and school paper contests;
  - 2.3 hone the linguistic macro-skills of learners in foreign languages aside from their vernacular language; and
  - 2.4 implement programs, projects, and activities aligned with the MATATAG Agenda and BULAKENYO flagship program on language literacy.
