SCHOOL MONITORING OF LIQUIDATION PROCESS IN SELECT SCHOOLS

- 1. The results of the monitoring of downloaded MOOE and Special Funds to the schools as of July 31, 2024 revealed negative balances. The abnormal balances came from errors during encoding of liquidation in the google sheets. As recommended by our resident Auditor, an intervention must be done to reduce these errors. In this regard, this Office will conduct a school monitoring of liquidation process in select schools on September 17 to 20, 2024, at 8:00 am to 5:00 pm.
- 2. The objectives of this walk though are:
 - a. To determine the causes of abnormal balances in the cash advances.
 - b. To correct the errors in the process and adjust balances in the financial statements.
 - c. To highlight the best practices of some schools in accounting for liquidation that can be adopted by other schools.
- 3. Attached herewith is Enclosure no. 1 Schedule of visit to select schools.
- 4. This office memorandum shall serve as travel authority of all concerned accounting unit personnel.
- 5. Transportation Expenses to be incurred in the activity shall be charged against the SDO MOOE Funds.
- 6. Immediate and wide dissemination of this Memorandum is desired.
