#### DIVISION TRAINING ON STANDARD FIRST AID FOR PROJECT DEVELOPMENT OFFICER I AND SELECT LAST MILE SCHOOLS FOCAL PERSON

- To: Assistant Schools Division Superintendents Division Chiefs Education Program Supervisors Public Schools District Supervisors Public Elementary and Secondary School Heads Elementary and Secondary School DRRM Coordinators All Others concerned.
  - 1. In reference to Republic Act 10871 known as the Samboy Lim's Law, sponsored by former senator and now DepEd Secretary Sonny Angara, and DepEd Order No. 54 s, 2021 titled Implementing Rules and Regulations of RA 10871" the Schools Division Office of Bulacan shall conduct a 4-day live-in seminar workshop for Division Standard First Aid Training on October 22 to 25, 2024 at a venue to be announced.
  - 2. This activity aims to:
    - a. Equip participants with the knowledge and skills to perform CPR and use other life- saving devices effectively in emergencies;
    - b. Teach individuals to recognize the signs of cardiac arrest, choking, and other life-threatening situations and respond promptly;
    - c. Foster confidence in participants to act in emergencies, reducing hesitation and increasing the likelihood of effective intervention; and
    - d. Increase awareness of the importance of early intervention and the chain of survival in improving patient outcomes.
  - 3. The participants to this training are the 34 PDO I and 12 select last miles school's focal person (see attached training matrix as Enclosure I and enclosure II list of participants and resource persons).
  - 4. The participants are encourage to wear comfortable clothes and rubber shoes suited to the activities.
  - 5. This Memorandum serves as the travel authority of all participants.
