 - (ii) Thirty percent (30%) of the total contract price in the form of surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security.

Failure to comply with these requirements shall constitute a sufficient ground for cancellation of this award, forfeiture of your Bid Security, and imposition of appropriate sanctions.


