#### DIVISION TRAINING FOR SCHOOL DRRM ADVOCATES

- 1. This Office announces the conduct of a three-day live-in training for new School DRRM Advocates on November 13-15, 2024 for both Elementary and Secondary Levels at Galilee Wonderland Resort, San Pedro, Bustos, Bulacan.
- 2. This activity aims to:
  - provide new SDRRM coordinators with fundamental knowledge on Disaster Risk Reduction and Management principles, including risk assessment, preparedness, mitigation, response, and recovery;
  - ensure that everyone understands their roles and responsibilities during emergencies; and
  - introduce significant mobile and web applications such as RADaR, necessary in accomplishing reports during disasters and calamities, for easy evaluation of damages and intervention.
- 3. Participants to this training are 3 untrained DRRM elementary advocates from each district to be identified by the public schools district supervisors and 1 untrained DRRM advocate from each secondary school to be identified by the school heads.
