**Contest Guidelines and Mechanics**

1. The On-the-Spot Poster Making Contest will commence face-to-face.
2. Only one (1) learner-participant will be allowed per District.
3. Participant will be given 3 hours to complete their posters.
4. The poster must be an original creation. If the submitted poster is found to have been plagiarized, it will be automatically disqualified.
5. Participants must bring all materials needed for the contest. Materials should include an illustration board (20" x 30").
6. Each-learner participant shall be accompanied by one (1) coach. However, coaches are only allowed to assist the participant during the set-up of materials on the day of the competition.
7. The top 3 winners will be selected and announced after the contest.
8. Upon joining the contest, participants shall submit a Parent-Learner Consent Form.
9. Failure to comply with any of the stated rules and guidelines will result in disqualification.
10. The decision of the Board of Judges is final and irrevocable.

**32<sup>ND</sup> CELEBRATION OF NATIONAL CHILDREN'S MONTH**

To : Schools Division Superintendents

 All Others Concerned

1. Pursuant to Republic Act No. 10661, titled "An Act Declaring the Month of November of Every Year as the National Children's Month," which mandates DepEd to facilitate and encourage the observance of celebration of the NCM in all public and private schools nationwide.

2. The Department of Education (DepEd) is one with the Council for the Welfare of Children (CWC), the National Youth Commission (NYC), the Department of Social Welfare and Development Council (DSWD), Local Government Units (LGUs) and Private and Civil Society Organizations in celebration of 32<sup>nd</sup> National Children's Month anchored to the theme "Break the Prevalence, End the Violence: Protection Children, Creating a Safe Philippines".

3. This year's National Children's Month celebration shall highlight on the prevention and addressing Violence Against Children (VAC). In addition, it shall cover the four categories of children's rights to wit:

- 3.1 Survival Rights (1<sup>st</sup> Week of November)
- 3.2 Development Rights (2<sup>nd</sup> Week of November)
- 3.3 Participation Rights/ National Play Advocacy (3<sup>rd</sup> Week of November)
- 3.4 Protection Rights/ Juvenile Justice Consciousness (4<sup>th</sup> Week of November)

4. Further, this activity aims to strengthen public awareness of the prevalence of VAC and advocate for implementation and enforcement of measures as well as empower learners, parents and duty bearers and communities to recognize and report incidents of violence against children.
