1.  - c. The unit/section head shall present the report using his/her laptop, and
 - d. It is highly advised to observe the assigned presentation date and time allotted for each unit/section.
 - e. It is also advise that all Unit heads are advice to join the preliminary program on the first day that shall begin at 8:30 AM.
5. After the presentation, unit heads shall incorporate the suggestions of the panel of reactors and submit the soft copy of the final 4th quarter PIR to the same drive (refer to 4. a) on the next day for consolidation of reports.
