### GUIDELINES AND CRITERIA FOR THE DIVISION VIDEO COMPETITION ON INTERPRETING DEPED BULACAN MARCH THROUGH ARTISTIC MOVEMENTS

- 1. Pursuant to Republic Act No. 9155 (Governance of Basic Education Act of 2001) Section 3: This law provides the legal basis for the Department of Education to oversee all aspects of basic education in the Philippines. It highlights the responsibility of the DepEd to develop and promote programs that support not only academic learning but also the holistic development of learners, which includes arts and culture fostering creativity, cultural awareness, and artistic expression. Hence, this Office announces the Division Video Competition on Interpreting DepEd Bulacan March Through Artistic Movements on February 4, 2025.
- 2. The aims of this competition are:
  - a. promote creative expression and foster appreciation for artistic excellence;
  - b. showcase the creativity and talent of the learners, teaching and non-teaching personnel in interpreting DepEd Bulacan March through artistic movements; and
  - c. create proper physical movements as the official interpretation for DepEd Bulacan March.
- 3. EDDIS chairs from both elementary and secondary levels are expected to arrange the EDDIS level competition. EDDIS winners shall serve as the official entry to the Division Level. They are expected to submit the results of the EDDIS-level competition on or before January 31, 2025, to the education program supervisor in charge of MAPEH.

- 5. Guidelines and criteria and the committees for this competition are attached in Enclosure No. 1 and Enclosure No. 2 respectively.
- 6. The expenses to be incurred relative to the conduct of this activity shall be charged against local school fund for the EDDIS level competition while at the division level, expenses shall be accounted against Division MOOE subject to usual accounting and auditing rules and regulations.

# GUIDELINES AND CRITERIA FOR THE DIVISION VIDEO COMPETITION ON INTERPRETING DEPED BULACAN MARCH THROUGH ARTISTIC MOVEMENTS

- 1. The competition is open to all DepEd Bulacan elementary and secondary public schools.
- 2. The group shall be composed of 15 to 20 members, combination of learners, teaching and non-teaching personnel. There are no required number of participants in the video.
- 3. There shall only be one champion per EDDIS to be the official entry in the Division Level.
- 4. The groups are advised to wear school uniforms.
- 5. No props are allowed. Only hand and body movements are required.
- 6. Video editing is allowed.
- 7. The decision of the board of judges is final and irrevocable.
