# DEADLINE OF SUBMISSION OF THE CERTIFICATE OF COMPENSATION PAYMENT/ TAX WITHHELD (FORM 2316) FOR THE YEAR 2024 TO THE DIVISION OFFICE

- This Office announces the deadline of submission of the Certificate of Compensation Payment/ Tax Withheld (Form 2316) for the year 2024 to the Division Office on or before February 7, 2025, at 12:00 noon.
- 2. Details of the deadline are as follows:
  - I. For schools within EDDIS 1 and EDDIS 2
    - a. Hardcopies of the Form 2316 in 3 copies (BIR copy, School copy, and Employee copy);
    - b. The hard copies must have complete details and duly signed by the employees;
    - Sworn Declaration (Annex "C") under RR No. 2-2015 to be signed by the Division Accountant
  - II. For schools within EDDIS 3 to 6
    - a. Encode all the details in the soft copies of Form 2316 and upload to the link provided per school (link sent to the employees in-charge of uploading and shall be closed at exactly 12:00 noon of Feb. 7, 2025)
    - Hardcopies of the Sworn Declaration (Annex "C") under RR
       No. 2-2015 to be signed by the Division Accountant
    - c. The e-signature of the Division Accountant shall be affixed by the SDO Accounting Unit staff to avoid unauthorized use in accordance with R.A. 8792 (Electronic Commerce Act of 2000) and R.A. 10173 (Data Privacy Act of 2012)
