

In this regard, a post-PAM conference, evaluation, and pre-CLRAA meeting will be held for all winning coaches, asst. coaches chaperons, all PAM Sports Events Tournament Managers, Secretaries, Members of the Secretariat, DSAC Chair and Co-Chairs, TRMC Chair and Co-Chair cum Meeting of all Elementary and Secondary EDDIS Chair/Sports Chair for the upcoming PAM2025-TNTS 2nd Superintendent Cup (2025 Edition) is slated on February 12, 2025, Wednesday at 1:00 PM at Guiguinto District Hall, Guiguinto Central School.
 - 4. Likewise, a medical examination and clearance of all winning athletes, coaches, asst. coaches, chaperons, and technical officials bound to CLRAA 2025 are scheduled on February 21, 2025, Friday 8:00 AM -4:00 PM at Plaridel District Hall/Covered Court, Plaridel Central School. Also, the fitting of uniform sizes will be facilitated.
- 5. The 2025 edition of the Central Luzon Regional Athletic Association (CLRAA) Meet is scheduled from **April 20 to 27, 2025**, to be hosted by the Provincial Government of Tarlac in coordination with the Schools Division Office of Tarlac Province. Hence, the Billeting Center of Team SDO Bulacan is at Capas National High School, Capas, Tarlac Province.

- 6. The Schedule of Local/Division Screening and Accreditation Committee (DSAC), Initiated Screening of revised Palarong Pambansa Forms is on February 26-28, 2025, at Guiguinto District Hall, Guiguinto Central School, Guiguinto Central School, while the Final Schedule of Regional Screening and Accreditation Committee (RSAC) with interview is on March 2025 (AM only) -final date TBA in the same venue. Coaches from both public and private schools are requested to coordinate closely with the DSAC Over-All Chair, Mr. Virgilio Alejandro, School Head of Taal Elementary School, Bocaue District, for the preparation and checking of requirements. In anticipation of latecomers, they can only have it in the afternoon on April 2025, TBA by RSAC (time and final venue).
- 7. Relative to the CLRAA Meet preparation, the intensive training of Team Bulacan Athletes is set to begin on **February 17 up to April 16, 2025.**

Under the school-based training schemes, financial support is sought from district supervisors and school heads through the Municipal Local School, board/canteen/school funds. Also, service credit shall be awarded to all trainers, coaches, and assistants coaches/chaperones of CLRAA 2025 bounded athletes from the public schools under SDO Bulacan. The School Sports Coordinator will prepare the **After School Sports Program and Training Matrix** with a cover letter and communication and, in accordance with the approved CSSP SSC1 and SSC2 forms, submit it to the division office addressed to the Schools Division Superintendent and attention to SGOD-Youth Formation and Sports Development Unit.

A separate memorandum will be issued regarding the information on the conduct of **Hosted Centralized Training-SDO-PGB SEF Funded beginning March 17, 2025**. Schools without players /representatives to the 2025 CLRAA Meet are also requested to provide their share of financial support to their district delegation.

9. Provincial Athletic Meet 2025-TNTS 2nd Superintendent Cup is scheduled during the last week of intensive training for CLRAA 2025 to be hosted by Guiguinto District between April 7 to 11, 2025. Awarding Ceremonies and CLRAA 2025 Team Bulacan Solidarity Meeting on April 11, 2025. The final Schedule and venue are TBA, and a separate memorandum will be released.

- 10. Athletes, coaches, chaperons, trainers, and officials must bring their bedding, mess kits, sleeping and playing clothes, rubber shoes, slippers, toiletries, etc. The SDO will provide the sleeping mattress.
- 11. Student-athletes of each delegation representing their EDDIS bounded to CLRAA 2025 shall automatically divert to Alternative Delivery Modality (ADM) through Modular and Online Learning Modes provided that their subject teachers shall consider the activity requirements to be completed and submitted by the student-athletes since they are engaged in the intensive training and the CLRAA 2025 proper. School Heads, as the Instructional Leaders of their respective schools, shall orient all the teachers involved in CLRAA 2025 and their respective subject teachers to

consider the student-athletes since the division is encouraged to balance academic and co-extra/co-curricular activities as learner support services.

- 12. Teachers and Teaching-Related Personnel who will serve as coaches, assistant coaches, chaperones, members of the delegations, and technical officials during the intensive training and CLRAA Meet 2025 proper shall be granted service credits pursuant to the provisions of DepEd Order No. 53, s. 2003 on the Updated Guidelines on Grant of Vacation Service Credits to Teacher while Non-Teaching Personnel/Teaching Related Personnel shall be entitled to Compensatory Time-Off (CTO) in accordance with Civil Service Commission and Department of Budget and Management Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered.
- 13. A monitoring team shall be organized to oversee the progress of the intensive training.
- 14. Proper decorum must be observed by all officials, coaches, chaperons, and athletes concerned. They are expected to perform their best for the productive participation of Team Bulacan in this regional conclave. A Parent's permit must be secured from all the athletes of Team Bulacan.
- 15. Coaches from private schools are requested to coordinate closely with DepEd Bulacan SGOD Supervisor & Division Sports Officer (Jay-Arr C. Tayao, DBA, EdD)/ PDO I Youth Formation and Sports Development Unit (Ron Dionisio V. Perez) at sgodbulacan@deped.gov.ph.
- 16. All expenses to be incurred relative to the conduct of this activity, like school-based and subsidized training, which shall be taken from the support given by Municipal LSB/schools/other sources and SEF-funded training shall be charged from the 2025 Provincial Special Education Funds, subject to the usual accounting and auditing rules and regulations.
- 17. All concerned are reminded to adhere strictly to the health and safety protocols against COVID-19.
- 18. This Memorandum shall serve as the travel authority of all concerned.
- 19. Strict compliance with the foregoing instructions is enjoined.
- 20. Immediate and wide dissemination of this Memorandum is desired.
