THE 2025 PROVINCIAL-LEVEL ELECTION OF BOY AND GIRL OFFICIALS

- 1. As part of the 2025 Bulacan Boy/Girl Officials Program, the Provincial Government of Bulacan will conduct the 2025 Provincial-Level Election of Boy and Girl Officials on August 5, 2025, at 9:00 AM, at Mariano Ponce Hall, Hiyas ng Bulacan Convention Center, Capitol Compound, City of Malolos, Bulacan. During the said activity, an election will be conducted to select the Provincial Boy and Girl Officials that will assume the positions of Bulacan Provincial Government officials and heads of offices on August 11-14, 2025. This program is an integral part of the annual celebration of "Linggo ng Kabataan" which aims to provide the youth a meaningful understanding of the democratic process and local governance as mandated by Republic Act No. 10742 or the SK Reform Act of 2015.
- 2. The objectives of the 2025 Bulacan Boy/Girl Officials Program are the following:
 - a. To provide the youth insights on what the government can do for them and what they can do for their government;
 - b. To provide them an opportunity to project their roles to the community where they live; and
 - c. To develop awareness of their future roles as responsible citizens and leaders.
- 3. The participants in this activity are the municipal-level Boy and Girl Officials' provincial election representatives, their respective Supreme Secondary Learner Government (SSLG) teacher-advisers, and the Division Youth Formation Coordinators. The learner-participants shall wear their school uniforms, while the SSLG teacher-advisers and Division Youth Formation Coordinators shall wear their respective Tuesday DepEd employees' uniforms in participating in the said activity.
- 4. This Division Memorandum shall serve as the Travel Authority of all participants in the said activity.



GUIDELINES FOR THE CONDUCT OF BOY/GIRL OFFICIAL CY 2025

1. BACKGROUND:

In accordance with Chapter VI of Republic Act No. 10742 or "SK Reform Act of 2015", every barangay, municipality, city and province shall conduct an annual activity to be known as the "Linggo ng Kabataan" on the week where the 12th of August falls to coincide with the International Youth Day. The Sangguniang Kabataan, in the case of barangay, and the respective LYDC in cooperation with the Pederasyon ng mga Sangguniang Kabataan, in the case of municipality, city and province, shall take the lead in this observance".

Further, under Rule VI, Section 33 of its Implementing Rules and Regulations, the observance of the "Linggo ng Kabataan" shall include the election of counterparts of all local elective and appointive officials, as well as heads of national offices or agencies stationed or assigned in the territorial jurisdiction of the local government unit, among in-school and community youth residing in the local government concerned from ages thirteen (13) to seventeen (17). During the said week, they shall hold office as Boy/Girl Official and perform the functions and duties.

OBJECTIVES:

- 1. To provide the youth insights on what the government can do for them and what they can do for their government.
- 2. To provide them an opportunity to project their roles to the community where they live.
- 3. To develop awareness of their future roles as responsible citizens and leaders.

TARGET PARTICIPANTS:

The participants for the program are *Bulakenyo* youth ages 13 to 17 whether in-school or community youth.

PLAN OF ACTION;

During the period of August 8-14, 2025, the selected BOY/GIRL OFFICIALS will assume the positions of officials and head of offices which they represent in the provincial, city, municipal and barangay levels in the province of Bulacan.

2. REGISTRATION PROCESS:

The registration for the participating youth will start on June 9, 2025, 9:00 AM to 4:00 PM to be facilitated by the Barangay Chairman, Sangguniang Kabataan Chairman (Ex-Officio Barangay Member and Chairman of the Committee on Youth and Sports) and the Secretary of the Sangguniang Barangay. They shall also designate a public area within the barangay for the conduct of the registration.

3. SELECTION PROCESS:

3.1 BARANGAY LEVEL - All registered youth shall be convened to an assembly on July 5, 2025 (Saturday) 1:00 PM at a designated place by the Barangay Chairman, in coordination with the barangay officials and DepEd Principals/Head Teachers. They shall elect among themselves the following Boy/Girl Officials:

Barangay Chairman (1) Barangay Secretary (1)
Barangay Councilman (7) Barangay Treasurer (1)

Barangay Tanod Chief (1) Sangguniang Kabataan (SK) Chairman (1)

Before electing the Barangay Chairman, they shall elect first one (1) barangay representative for the municipal level elections. In case the number of barangay representatives are not sufficient to fill the positions of the city/municipal officials, two (2) or three (3) barangay representatives may be selected.

3.2 MUNICIPAL LEVEL - Elected Boy/Girl Barangay representatives shall be convened to an assembly on July 18, 2025 (Friday) at 9:00 AM to 11:00 AM at the City/Municipal Session Hall to elect among themselves the following Boy/Girl Officials:

Before electing the city/municipal mayor, they shall first elect two (2) city/municipal representatives for the provincial elections.

3.3 PROVINCIAL LEVEL - All city/municipal representatives shall convene at the Francisco Balagtas Hall, Hiyas ng Bulacan Convention Center, Capitol Compound, City of Malolos, Bulacan on July 30, 2025 (Wednesday), 8:00 AM, to attend the briefing/orientation on Local Government Administration. Election shall follow at 1:00 PM for the following positions for provincial Boy/Girl;

4. CONDUCT OF ELECTORAL PROCEEDINGS

- 4.1 PROVINCIAL The election/selection of Provincial Officials and Heads of Offices shall be managed by the Project Implementation Committee composed of the Provincial Youth and Sports Development Office (PYSDO), Schools Division Superintendent (DepEd), Provincial DILG Officer and Provincial Election Supervisor.
- 4.2 MUNICIPAL The election/selection of City/Municipal Officials and Heads of offices shall be managed by the Project Implementation Committee composed of the Mayor's Office to be assisted by their respective Youth Development Office or appointed/designated Local Youth Development Officer (LYDO) and coordinated with the DepEd Supervisor, City/Municipal DILG Officer and City/Municipal Election Officer.

4.3 BARANGAY - The election/selection of Barangay Officials shall be managed by the Project Implementation Committee Barangay composed of the Councils and DepEd Principal/Head Teacher.



6. MECHANICS OF IMPLEMENTATION:

- 6.1 OVERALL COMMITTEE & ADVISORY BOARD The Provincial Youth and Sports Development Office (PYSDO) and Department of the Interior and Local Government (DILG) shall be the Overall Committee tasked with the formulation and implementation of the concept and guidelines of the BOY/GIRL OFFICIAL 2025. They shall also act as the Advisory Board of the whole program.
- 6.2 SELECTION & ELECTORAL PROCEEDINGS The Project Implementation Committee of the Provincial, City/Municipal and Barangay shall take charge of all the activities regarding the selection and electoral proceedings of the program. They shall be tasked also with the implementation of this guidelines and supervise the day-to-day activities of the program.
- 6.3 INFORMATION DISSEMINATION The Project Implementation Committee is encouraged to widely disseminate the information on the conduct of Boy/Girl activities by posting the information in publicly accessible and conspicuous places and in the social media.
- 6.4 ORIENTATION/ BRIEFING The PYSDO shall take charge of all preparation and conduct of an Orientation/Briefing to all provincial Boy/Girl Officials 2025. For the city/ municipal Boy/Girl Officials, the orientation/briefing shall be led by the Mayor's Office assisted by its Youth Development Office or LYDO, if any. The orientation for the barangay Boy/Girl Officials shall be led by the Barangay Council officials. The orientation/briefing shall give emphasis on the organizational structure and the tasks and functions of the officials.
- 6.5 PARENTAL CONSENT & LETTER FOR OFFICIAL ATTENDANCE The Parental Consent Form and Letter addressed to the School Heads for the Boy/Girl Official's five (5) day attendance to their functions under the program shall be provided during the orientation/briefing.
