Basic Life Support Training for Schools Division Personnel

To: Assistant Schools Division Superintendents

All Others concerned.

- 1. In reference to Republic Act 10871 known as the Samboy Lim's Law, sponsored by former senator and now DepEd Secretary Sonny Angara, and DepEd Order No. 54 s, 2021 titled Implementing Rules and Regulations of RA 10871" the Schools Division Office of Bulacan shall conduct a 3-day seminar workshop for Division Basic Life Support Training for Schools Division Personnel on August 26-28, 2025 at a venue to be announced.
- 2. This activity aims to:
 - a. Equip participants with the knowledge and skills to perform CPR and use other life- saving devices effectively in emergencies.
 - b. Teach individuals to recognize the signs of cardiac arrest, choking, and other life-threatening situations and respond promptly.
 - c. Foster confidence in participants to act in emergencies, reducing hesitation and increasing the likelihood of effective intervention; and
 - d. Increase awareness of the importance of early intervention and the chain of survival in improving patient outcomes.
