- 1. Anent with Unnumbered Memorandum issued last July 17, 2025, from the Office of the Undersecretary for Finance, on the Guidelines on the Budget Allocation and Fund Utilization for the Academic Recovery and Accessible Learning (ARAL) Program, this Office announces the downloading of funds among elementary and secondary schools implementing the ARAL Program, SY 2025 2026. Attached is the list of schools with the number of learner-beneficiaries and the corresponding funds to be downloaded among schools as reference. The funds shall be used to support activities and expenses under the ARAL Program, which includes:
  - Provision and Distribution of Teacher and Learner Resources; and
  - · Orientation Activities.
- 2. The project objective is to support activities and expenses under the ARAL Program. In return, the ARAL Program aims to enhance the reading skills of the identified struggling readers, as measured by their performance on the CRLA and PHIL-IRI assessments. Support objectives are as follows:
  - Address Learning Losses: Provide targeted support to learners struggling in critical subjects in reading, particularly those affected by the COVID-19 pandemic.
  - Improve Foundational Skills: Enhance literacy competencies for Kindergarten to Grade 10 learners.
  - Accessible Learning: Offer free, flexible learning interventions through faceto-face, online, or blended tutoring modes.
  - Holistic Development: Foster socio-emotional skills alongside academic growth.
- 3. It is reiterated that the eligible expenses for this downloaded fund shall be solely for the Provision and Distribution of Teacher and Learner Resources and Orientation Activities.
- 4. All school heads are hereby instructed to lead in the management and preparation of the following documents once the fund is downloaded. The following documents must be submitted to form part of the liquidation report:
