In compliance with the Implementing Rules and Regulations of Republic Act 10588, an Act Institutionalizing the Conduct of the Palarong Pambansa, Section 18 and anent to DepEd Memorandum No. 49, s. 2018, and projected in DepEd Memorandum OM-OUOPS-2025-05-04336 entitled Conference of National, Regional and Division Screening and Accreditation Committee, the Schools Division Office of Bulacan, in coordination with Bulacan Schools Sports Association, Inc. (BSSA) in preparation for 66th Edition of the Palarong Pambansa to be Hosted by Agusan del Sur in 2026.
2. - c. express commitment in ensuring the protection of athletes' rights pursuant to DepEd Order No. 40 s. 2012 also known as Child Protection Policy and RA 10676: Student-Athletes Protection Act.

Target participants to the Conference are the EDDIS Chairman of EDDIS Screening and Accreditation Committee (ESAC), Secondary and Chairpersons of District Screening and Accreditation Committee, Bulacan Private Schools Athletic Association (BulPRISAA), San Miguel National High School (SMNHS), National Vocational Schools Athletic Association (NVSAA) Screening Chair or their respective authorized representatives, and Members of Division Screening and Accreditation Committee (DSAC), Bulacan Schools Sports Association, Inc. (BSSA), and other relevant offices.
 5. All expenses to be incurred relative to the conduct of this activity, like school-based and subsidized training, shall be taken from the support given by the Bulacan Schools Sports Association, Inc. Fund, subject to the usual accounting and auditing rules and regulations.
