**Extension of the 2025 Accreditation and Equivalency (A&E) Test
Registration**

Relative to DepEd Memorandum No. 100, s. 2025, titled "2025 Accreditation and Equivalency (A&E) Test Registration and Administration Guidelines" and subsequent to the class and work suspensions due to Typhoon Tino and Super Typhoon Uwan, the following information is disseminated relevant to the extension of the 2025 A&E test registration, data submission, and other activities:

1. The Regional and Division Testing Coordinators, as well as the ALS Focal Persons, are reminded to strictly adhere to the adjusted timeline of activities.

Submission of Enclosure Nos. 3 and 4 by the Division Testing Coordinators and Division ALS Focal Persons to the Regional Testing Coordinators (RTCs) and Regional ALS Focal Persons	November 24, 2025	November 24, 2025 to December 10, 2025
Submission of validated and consolidated Enclosure No. 4 per Schools Division Office (SDO) by the RTCs and Regional ALS Focal Persons to BEA	November 28, 2025	November 28, 2025 to December 16, 2025

2. The extension is being implemented to give the **Test Registration Officers (TROs)** ample time for test registration and evaluation of documentary requirements.
3. The **Education Program Specialist II for ALS (EPSA) or Division ALS Focal Person** shall serve as the TRO. The DTC shall oversee the registration process and evaluation of the A&E test applicants' documents. Support staff shall be assigned by the DTC if necessary.
