- 1. This Corrigendum is issued to inform all concerned of the change in schedule of the activity titled "VISIONed LRMDS: Transforming Learning Resources, Empowering Every Learner (Phase 1 Orientation, Planning, and LRMDS Systems Improvement)", originally set on November 12–14, 2025, and postponed due to the two-day suspension of classes brought about by Typhoon Uwan. The said activity shall now be conducted on **November 26-28, 2025**, at the same venue, Galilee Wonderland Water Park and Hotel Resort, Barangay Pinaod, Bustos, Bulacan.
- 2. All other content, objectives, and provisions stipulated in Division Memorandum No. 549, s. 2025 shall remain in full force and effect.

  - two (2) representatives from each Elementary District composed of the designated Learning Resource Adviser and Learning Resource Coordinator;
  - c. five (5) Learning Resource Focal Persons from each Secondary EDDIS;
  - d. all licensed school librarians are likewise required to register and participate in this activity to ensure alignment of school library services with the Division's LRMDS systems; and

- e. presidents of the Education Program Supervisors (EPS) group and of the Public Schools District Supervisors (PSDS) group shall also attend to strengthen leadership collaboration and inter-district coordination.
- 6. All participants are reminded to **bring any reading material of their choice**, such as a pocketbook, professional magazine, religious book, comic, or any favorite reading piece that sparks personal interest. These materials will be used in one of the reflective and interactive activities during the session.
- 7. Expenses relative to this activity shall be charged against the Division In-Service Training (INSET) Fund and other authorized sources, subject to the usual accounting and auditing rules and regulations.
- 8. This Memorandum shall likewise serve as the updated Travel Authority of all participants who have confirmed their registration through the abovementioned link.
