**PROFILING OF PROSPECTIVE TAKERS FOR NATIONAL ASSESSMENT FOR
SCHOOL HEADS (NASH) BATCH 2 FOR FISCAL YEAR 2025**

1. In preparation for the possible administration of the National Assessment for School Heads (NASH) Batch 2, this Office announces the conduct of the profiling of prospective takers. This shall follow the evaluation and validation process for the FY 2025 NASH application, based on the parameters and qualification standards set in DepEd Memorandum No. 69, s. 2025, Administration of the National Assessment for School Heads (NASH) for Fiscal Year 2025, and DepEd Memorandum DM OUHROD-2025-2392, Supplemental Guidelines on the Validation and Final Submission of Takers of FY 2025 National Assessment for School Heads (NASH) Batch 1.
2. Pursuant to the provisions of DepEd Memorandum No. 69, s. 2025, the following personnel are considered prospective takers for FY 2025 NASH Batch 2:
 - a. Head Teachers and Assistant School Principals (whether or not they meet the QS for School Principal I)
 - b. FY 2021 NQESH Category C takers
 - c. FY 2023 NQESH Category B and C takers
 - d. For other personnel who are qualified, below is the new CSC-Approved Qualification Standards for School Principal I:

School Principal I	19	Master's degree in Education, or Educational Management, or Educational Leadership; or Master's degree in relevant learning area with at least 9 units in Management	5 years teaching experience and 1 year relevant experience in any of the following: learning area coordination, subject area supervision, school management and operations, instructional supervision	32 hours of training in any of or a cumulative of the following: Curriculum, Pedagogy, School Management and Operations, Instructional Leadership acquired within the last 5 years	RA 1080, as amended (Teacher)
