Anent to DepEd Memorandum No. 169 s. 2025 from the Office of the Undersecretary for Learning Systems on the Request for Teacher Data for the Revised Grades 6, 9, and 10 Curriculum Training, this Office shall gather the needed teachers' information in preparation for the Revised Grades 6, 9, and 10 Curriculum Training on or before December 9, 2025.
