**DIVISION ORIENTATION ON THE IMPLEMENTATION OF SPECIAL CURRICULAR PROGRAMS IN JOURNALISM AND FOREIGN LANGUAGES**

To further optimize the journalistic skills and multilingual competence of learners through Project SPCJ (Sustaining Performance in Campus Journalism) and Project FLIS (Foreign Language Interest of Students), this Office shall conduct a Division Orientation on the Implementation of Special Curricular Programs in Journalism and Foreign Languages on January 21, 2026, Wednesday, 9:00 a.m., using MS Teams.
2. This initiative has the following objectives:
  - 2.1 support the public and private elementary and secondary school learners on their special interest programs;

  - 2.3 hone the linguistic macro-skills of learners in foreign languages aside from their vernacular and foreign languages; and
  - 2.4 implement programs, projects, and activities aligned with the DepEd 5-Point Agenda and BULAKENYO flagship program on language literacy.
