**ADMINISTRATION OF THE REGULAR PHILIPPINE
EDUCATIONAL PLACEMENT TEST (PEPT)**

1. In line with the DepEd Memorandum No. 098, s. 2025 titled Administration of the Regular Philippine Educational Placement Test, and Advisory No. 001, s. 2026 of Bureau of Education Assessment on the Schedule of Administration of the Regular Philippine Educational Placement Test (PEPT), this Office announces the **Administration of Regular Philippine Educational Placement Test (PEPT)** on February 15, 2026, at Bajet-Castillo High School, Pulilan, Bulacan.
2. The PEPT is a nationally administered assessment for learners in special circumstances. The result of this assessment will allow these learners to access or resume schooling and/or obtain certification of completion by grade level in the DepEd formal system.
3. All interested applicants can access the **Application Form** through this link: [Regular PEPT Registration Form.pdf](#). Duly accomplished application form with the documentary requirements listed in this Memorandum shall be submitted to the Office of the Curriculum Implementation Division through Ms. Rem Sulit on or before February 12, 2026.
4. Learners with the following circumstances are eligible to take the PEPT.
 - a. Learners from schools without a government permit,
 - b. Learners from nonformal and informal education programs,
 - c. Learners who have incomplete or no record of formal schooling,
 - d. Learners with back subjects,
 - e. Learners who need grade-level standards assessment, and
 - f. Learners who are overage for their grade levels.

5. Pursuant to Section 6 (Grade Level Placement Assessment) of DepEd Order No. 55, s. 2016 titled Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program, the placement of the Regular PEPT qualifiers shall take effect in the next or subsequent school year, not during the current school year when the test was administered.
5. There is **NO TEST REGISTRATION FEE** shall be collected from the test registrants.
6. Due to limited allocation of test materials, **NO WALK-IN POLICY** shall be implemented.
7. Documentary requirements to be submitted by the test registrants with the PEPT Application Form:
 - a. **For new test-takers**
 - Original and one photocopy of the birth certificate duly authenticated and issued by the Philippine Statistics Authority (formerly National Statistics Office) or by the Local Civil Registrar
 - Certified True Copy of the permanent school record (e.g., SF10/Form 137) signed by the school principal/registrar/school administrator) with dry seal
 - Certificate of attendance in intervention programs, or any proof of schooling (if applicable)
 - Two identical and recently taken 1x1 colored ID pictures with name tags
 - One copy of the accomplished Regular PEPT Registration Form
 - b. **For test retakers and PEPT passers**
 - Original and one photocopy of the PEPT Certificate of Rating
 - Two identical and recently taken 1x1 colored ID pictures with name tags
 - One copy of the accomplished PEPT Registration Form
8. Qualified examinees shall be in the testing venue on or before 7:00 am with Mongol pencil lead #2, black ballpen, morning and afternoon snacks, and packed lunch.
9. An online orientation with the testing personnel shall be conducted on February 04, 2026 via MS Teams. The meeting link shall be provided with the identified testing personnel on or before the said orientation.
10. Forms and documentary requirements can be submitted to the CID Office, SDO Bulacan, from the release of this memorandum until February 13, 2026.
