1. Anent to DM-OULS-2026-003 with a subject on the **Extension of the Administration of the Computer-Based National Career Assessment Examination (CB-NCAE)** and DepEd Memorandum No. 108, s. 2025 titled **Administration of the Computer-Based National Career Assessment Examination (CB-NCAE)**, this Office announces the Extension of the Testing Window for CB-NCAE. The extended testing window is until February 28, 2026. However, due to the availability of resources and emergency situations, a specific testing window is given to the following:



Secondary Schools	Testing Window
Public	January 26 to February 20, 2026
Private	January 26 – February 6, 2026

2. All School Heads/Chief Examiners are encouraged to schedule the school's CB-NCAE as early as possible within the testing window, for possible challenges to be encountered due to the huge number/multiple users of the system.
3. All Public Schools District Supervisors, together with the CB-NCAE team and support staff, are expected to provide technical assistance among public and private secondary schools during the monitoring period (before and during the testing window).
