All teaching personnel who will serve as members of the DSAC in the PAM 2026 and serve as Coaches, Assistant Coaches, Chaperons, Members of the PAM Committees, and Tournament Officials on the affected reschedule dates shall be granted service credits under the provisions of DepEd Order No. 53, s. 2003 on the Updated Guidelines on Grant of Vacation Service Credits to Teachers, while Non-Teaching Personnel/Teaching Related Personnel shall be entitled to Compensatory Time-Off (CTO) by Civil Service Commission and Department of Budget and Management Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered.
