In line with our continuing commitment to the protection, welfare, and best interests of school-children, this Office disseminates the 2025 Revised Protocol for the Case Management of Child Victims of Abuse, Neglect, Exploitation, and Discrimination (CANE+D). The revised protocol aims to strengthen and standardize procedures for the identification, reporting, referral, intervention, and monitoring of child victims of CANE+D. It emphasizes a child-centered, rights-based, and trauma-informed approach, and reinforces inter-agency coordination to ensure timely, effective, and appropriate responses.
