**ADDITIONAL INFORMATION IN THE ADMINISTRATION OF THE  
END-OF-THE-SCHOOL-YEAR (EOSY) ASSESSMENTS FOR  
SCHOOL YEAR 2025-2026**

1. In line with the Unnumbered Memorandum dated February 2, 2026, titled Administration of the End-Of-The-School-Year (EOSY) Assessments for School Year 2025-2026, this Office reiterates some information on the conduct of the administration of the End-of-the-School-Year (EOSY) assessments. The Comprehensive Rapid Literacy Assessments (CRLA), Philippine Informal Reading Inventory (PHI-IRI), and Rapid Mathematics Assessment (RMA) shall be administered to all Grades 1 to 10 learners from February 18 to March 18, 2026. However, to facilitate all the processes with ease, the testing window for the said assessments shall be from **February 18 to March 13, 2026**. Then, from March 16 to 18, 2026, shall be spent in the collection and reporting of assessment results.
2. Attention is invited to the following notations:
  - a. **Comprehensive Rapid Literacy Assessment (CRLA)**
    - It will be administered only to learners who are still part of the Remediation Program (ARAL Program) or to those who continued in the said program after the Middle-of-the-School-Year (MOSY) Assessment.
  - b. **Phil-Informal Reading Inventory (Phil-IRI)**
    - It will be given to learners who are still part of the Remediation Program (ARAL Program) or to those who continued in the said program after the Middle-of-the-School-Year (MOSY) Assessment.
    - Identified learners will no longer take or undergo the Phil-IRI Group Screening Test (GST). Instead, they will proceed directly to the

Individualized Phil-IRI Assessment using the Phil-IRI graded passages found in the Phil-IRI Toolkit.

**c. Rapid Mathematics Assessment**

- All learners across Key Stages (Stage 1, 2, and 3) shall take the Rapid Mathematics Assessment (RMA) for the End-of-the-School-Year (EOSY) Assessment.

  4. All schools are required to submit the assessment results through the submission link: <https://bld.deped.gov.ph/submission> on or before March 20, 2026.

This Memorandum provides guidance on the conduct of the **end-of-the-school-year (EOSY) assessments** nationwide for the School Year (SY) 2025-2026.

The Comprehensive Rapid Literacy Assessments (CRLA), the Philippine Informal Reading Inventory (Phil-IRI), and the Rapid Mathematics Assessment (RMA) shall be administered to **all Grades 1 to 10 learners** from **February 18 to March 18, 2026**.

Table 1 presents the details of the administration of the EOSY assessments for SY 2025-2026

Regional Offices and Schools Division Offices are requested to designate a representative who can provide technical assistance to schools requiring support in administering assessments and submitting assessment data. A separate advisory shall be issued for this purpose.

All schools are required to encode the results of these assessments after the completion of the EOSY assessments through the submission link: <https://bld.deped.gov.ph/submission>, **not later than March 20, 2026.**
