- 1) The *Department of Education-Schools Division of Bulacan* intends to apply the sum of *Eleven Million Five Hundred Eighty-Two Thousand Four Hundred Pesos Only (P11,582,400.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *PROVISION OF MEALS FOR THE 2026 SCHOOL-BASED TRAINING OF GRADES 6,9, and 10 TEACHERS ON THE REVISED K-12 BASIC EDUCATION CURRICULUM*. Bid is on a per lot basis. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2) The *Department of Education-Schools Division of Bulacan* now invites bids for the above Procurement Project using Competitive Bidding. Delivery of the Goods is required *within contract duration (actual dates of activity)*. Bidders should have completed, at least *one year* from the date of submission and receipt of bids, contracts similar to the Project with a value of at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the IRR of RA No. 12009.
- i)* Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 5) A complete set of Bidding Documents may be acquired by interested Bidders on *April 24, 2026*, from the address given below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Five Thousand Pesos only (P 5,000.00)*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6) The Department of Education – Schools Division of Bulacan will hold a **Pre-Bid Conference** on **May 2, 2026**, at 10:00 AM via online platform. The link for the conference will be sent to the participants prior to the scheduled date. This shall be open to all prospective bidders.
- 7) **Bids must be duly received** by the Bids and Awards Committee (BAC) Secretariat through *manual submission* at the office address indicated below, **on or before May 14, 2026, at 9:59 AM**. Late bids shall not be accepted.
- 8) All Bids must be accompanied by Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.
- 9) **Bid opening** shall be on **May 14, 2026, at 10:00 AM** at the *Schools Division Office, Capitol Compound, Brgy. Guinhawa, City of Malolos*. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
- 10) The *Department of Education-Schools Division of Bulacan* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70<sup>1</sup> of R.A. No. 12009, without incurring any liability to the affected Bidder or Bidders.
