1. This Memorandum is issued to provide addendum and corrigendum to the previous guidelines regarding the "Kumustahan Caravan," which serves as the primary mechanism for the Office Performance Commitment and Review Form (OPCRF) validation of SDO Bulacan.
2. In addition, the School-Based Management (SBM) validation will now be integrated into the caravan. It is important to note the following parameters for this integration:

 - b. This activity is not intended to gauge or reassess official SBM Levels. It is designed as a supportive mechanism to ensure continuous improvement in school governance.
