Learners who are unable to attend regular classes due to intensive training shall be provided with the appropriate Alternative Delivery Modality (ADM), such as modular or online learning, as applicable. Subject teachers shall ensure that activity requirements are given reasonable consideration and that student-athletes are provided with opportunities to complete and submit their academic requirements while participating in the CSSPs SSC After-School Sports Program. School Heads, as the instructional leaders of their respective schools, shall orient all teachers involved in the sporting events, the subject teachers of the student-athletes, as well as the parents or guardians of the participating learners, on the implementation of these guidelines. This is to ensure a shared understanding of their respective roles and responsibilities in supporting the academic progress and athletic development of the student-athletes, while maintaining a balance between academic requirements and co-curricular and extra-curricular activities as part of learner support services.

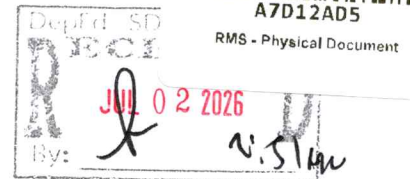

Maraming salamat sa patuloy na pagsuporta sa mga atletang Bulakenyo.

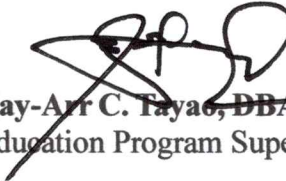
