**2026 OPLAN KALUSUGAN SA DEPED - HEALTHY LEARNING  
INSTITUTION (OKD-HLI) ACTIVITIES AND DIVISION RECOGNITION**

1. Pursuant to DepEd Memorandum OU-OUOPS-2026-00-1414 dated June 19, 2026 entitled "2026 Oplan Kalusugan sa DepEd-Healthy Learning Institutions (OKD-HLI) Activities," all public elementary, integrated, and secondary schools in the Schools Division of Bulacan are hereby enjoined to support and participate in the implementation of the Healthy Learning Institutions (HLI) Framework and the corresponding recognition process for School Year 2025-2026.
2. The Healthy Learning Institutions (HLI) Framework, institutionalized through Joint Administrative Order No. 2022-0001, serves as the guiding framework for Oplan Kalusugan sa DepEd (OKD) and promotes a whole-school approach in creating safe, healthy, and supportive learning environments.
3. In preparation for the recognition process, all interested school heads shall ensure the accomplishment of the School Self-Appraisal Checklist (SAC) and the preparation of the corresponding Means of Verification (MOVs) following the prescribed guidelines.
4. The following activities and timelines shall be observed:

August 25, 2026	Submission of school SAC and its MOVs for SY 2025-2026 to SDO Nurses

Before October 23, 2026	Endorsement of qualified schools for Joint Regional Validation
October 26- November 20, 2026	Joint Regional Validation by DOH CHDs and DepEd ROs/SDOs
November 23, 2026	Endorsement of qualified schools to DOH and DepEd Central Office for National Validation
December 2026	National Validation and concurrence of the National Technical Working Group for HLI (NTWG-HLI) for FY 2026 list of recognized HLIs
January 2027	Release of Official list of recognized HLIs for FY 2026

5. School Heads shall:

- a. lead the accomplishment of the School Self-Appraisal Checklist (SAC);
- b. ensure the completeness, accuracy, and organization of all required MOVs;
- c. submit one (1) consolidated SAC with complete supporting documents on or before September 1, 2026;
- d. facilitate coordination with district and division focal persons regarding concerns related to the implementation and validation process; and
- e. ensure active participation in all OKD-HLI activities and validation requirements.

6. Public Schools District Supervisors are requested to monitor compliance of schools within their respective districts and provide necessary technical assistance to ensure timely submission of requirements.

7. The School Governance and Operations Division, through the School Health and Nutrition Unit and the Division OK sa DepEd Coordinators, shall provide technical assistance, monitoring, and guidance to all schools throughout the implementation and recognition process.

8. Immediate dissemination of and compliance with this Memorandum is desired. For information and guidance.
