 - 2.4. Discuss the requirements for Government Recognition to ensure that private SHS implementers comply with DepEd quality standards and regulatory requirements for the continuous delivery of quality, accessible, accountable, and learner-centered Senior High School education.
 - 2.5. Address concerns and clarifications from private school stakeholders.
 - 2.6. Orientation on the Government Recognition of Senior High School.
