1. Pursuant to DepEd Order No. 40, s. 2012 titled "DepEd Child Protection Policy", DepEd Order No. 90, s. 2025 titled "Revised Implementing Rules and Regulations of Republic Act No. 10627, otherwise known as the Anti-Bullying Act of 2013, DepEd Order No. 006, s. 2026 titled "Guidelines on Ensuring a Safe and Motivating Learning Environment, and DepEd Order No. 18, s. 2015 titled "DepEd Guidelines and Procedures on the Management of Children-at-Risk (CAR) and Children in Conflict with the Law (CICL), the Department of Education (DepEd) is mandated to provide special protection to learners who were abused, discriminated against, bullied, threatened or endangered by circumstances which affect their normal development and over which they have no control, and assist the concerned agencies in the rehabilitation of affected learners.
2. In this regard, the DepEd Region III remains steadfast in its commitment to the protection to the protection of learners through the implementation of the Learner Rights and Protection (LRP) Specialization Course. This reflects a continuing commitment to safeguard the welfare, dignity, and well-being of every learner and further strengthen the implementation of DepEd policies on Child Protection and to reiterate DepEd's zero tolerance policy for any act of child abuse, exploitation, violence, discrimination, bullying, and other forms of abuse.
3. Further, this Office announces the list of trained and certified Child Protection Specialists (CPSes) of the DepEd Schools Division of Bulacan (DepEd SDO Bulacan) who are equipped with the necessary knowledge, skills, and competencies to uphold learner rights and strengthen child protection mechanisms in schools. Please see attached Regional Memorandum No. 257, s. 2026 and Enclosure No. 1 for reference.

4. The responsibilities and tasks of the CPSes shall be as follows:

a. **Provide Technical Advice/Guidance and Referral of Cases**

The CPSes shall provide timely advice to the school or schools division relative to complex and serious child protection cases such as, but not limited to, child abuse, discrimination against children, child exploitation, violence against children in school, corporal punishment, bullying or peer abuse and similar acts of violence or abuse defined in DepEd Order No. 40, s. 2012, DepEd Order No. 090, s. 2025, and DepEd Order No. 006, s. 2026. The CPSes shall likewise assist in the referral of Children-at-Risk (CAR) of Children in Conflict with the Law (CICL) to the Proper agency for further assessment or intervention, in accordance with DepEd Order No. 18, s. 2015. Child protection cases shall be referred to the designated CPS from the school's division where the case occurred.

b. **Network-Building**

The CPSes shall network and liaise with the different government and nongovernment agencies involved in Child Protection for the referral of complex and serious child protection cases. The CPSes, in coordination with the Division Learner Rights and Protection Focal Person (DLRPPF), shall likewise develop and update a directory of resources which can easily be accessed and used by the parties in the referral of cases.

c. **Monitoring of Actions Taken**

The CPSes shall follow up with the School Heads on the recommended actions and the actual actions taken on the cases reported to them. The CPSes shall likewise assist in the monitoring of the cases referred to other appropriate agencies for further assessment or case management.

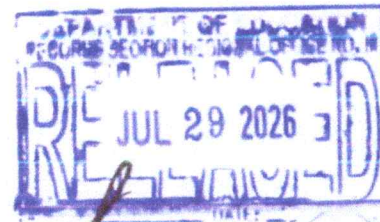

1. Pursuant to DepEd Order No. 40, s. 2012 entitled DepEd Child Protection Policy, DepEd Order No. 90, s. 2025 entitled Revised Implementing Rules and Regulations of Republic Act No. 10627, Otherwise Known as the Anti-Bullying Act of 2013, DepEd Order No. 006, s. 2026 entitled Guidelines on Ensuring a Safe and Motivating Learning Environment, and DepEd Order No. 18, s. 2015 entitled DepEd Guidelines and Procedures on the Management of Children-at-Risk (CAR) and Children in Conflict with the Law (CICL), the Department of Education is mandated to provide special protection to learners who abused, discriminated against, bullied, threatened or endangered by circumstances which affect their normal development and over which they have no control, and assist the concerned agencies in the rehabilitation of affected learners.

2. The DepEd Region III remains steadfast in its commitment to the protection of learners through the implementation of the Learner Rights and Protection (LRP) Specialization Course. This reflects a continuing commitment to safeguard the welfare, dignity, and well-being of every learner and further strengthen the implementation of DepEd policies on Child Protection and to reiterate DepEd's zero tolerance policy for any act of child abuse, exploitation, violence, discrimination, bullying, and other forms of abuse.

3. Further, this Office announces the list of trained and certified Child Protection Specialists (CPS) who are equipped with the necessary knowledge, skills, and competencies to uphold learner rights and strengthen child protection mechanisms in schools. See Annex A for reference.

4. The responsibilities and tasks of the CPS shall be as follows:

- a. **Provide Technical Advice/Guidance and Referral of Cases.** The CPS shall provide timely advice to the school or schools division relative to complex and serious child protection cases such as, but not limited to, child abuse, discrimination against children, child exploitation, violence against children in school, corporal punishment, bullying or peer abuse and similar acts of violence or abuse defined in DO No. 40, s. 2012 and DO No. 90, s. 2025, DO No. 6 s, 2026. The CPS shall likewise assist in the

referral of Children-at-Risk (CAR) or Children in Conflict with the Law (CICL) to the proper agency for further assessment or intervention, in accordance with DO 18, s. 2015. Child protection cases shall be referred to the designated CPS from the school's division where the case occurred.

For purposes of this policy, complex child protection cases are those which involve two or more victims or two perpetrators, while serious child protection cases shall be those which result in serious physical injuries or death, those which involve any kind of sexual abuse, or those which require professional or medical intervention.

- b. **Network-Building.** The CPS shall network and liaise with the different government and nongovernment agencies involved in Child Protection for the referral of complex and serious child protection cases. The CPS, in coordination with the Division Learner Rights and Protection Focal Person (DLRPFP), shall likewise develop and update a directory of resources which can easily be accessed and used by the parties in the referral of cases.
- c. **Monitoring of Actions Taken.** The CPS shall follow up with the SH on the recommended actions and the actual actions taken on the cases reported to them. The CPS shall likewise assist in the monitoring of the cases referred to other appropriate agencies for further assessment or case management.
